# MITOLO FAMILY FARMS APPROACH TO ESG

## ENVIRONMENT

1. Greenhouse gas emissions: We will understand our emissions baseline by measuring our current greenhouse gas emissions and establish a timeline and target for emissions reduction by 30 June 2025.
2. Water: We will establish targets to reduce water inputs per unit of crop produced through improvements in water use efficiency including irrigation techniques by 30 November 2024. We will focus on water savings at our processing facilities through improved treatment and recycling.
3. Renewable Energy: We will pursue the adoption of renewable energy sources where commercially practical to do so.
4. Biodiversity: We will prioritise the application of organic and biological pest and disease control methods where commercially practical and cost efficient.
5. Soil Management: We will maintain the health of our soils through development of best practice technique for Regenerative Agricultural practices for improving Soil Carbon through post crop rotations and soil remediation, with a focus on biological solutions and salinity management.
6. Waste: We are focussed on reducing waste from our crops and packaging. We are pursuing strategies to improve use of whole of crop for potatoes and onions and are committed to implementing sustainable packaging for consumers by 2025.
7. Crop yields: We will actively invest in agronomic innovations to grow more high-quality product with less inputs, with a focus on varietal selection by region and improved farming techniques.

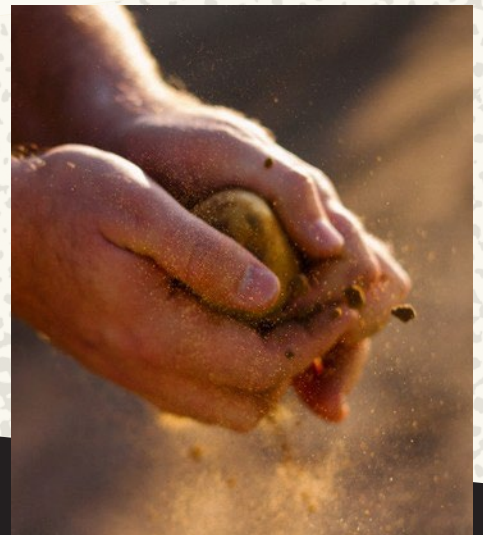


## OUR PEOPLE
